Karnataka Government circular exempts poultry farms from conversion of agricultural land.

In response to the suggestions put forward by the Karnataka Poultry Farmers and Breeders Association (KPFBA), the Karnataka Government recently issued a circular exempting the use of agricultural land for poultry farming from land conversion. The circular comes in the wake of several gram panchayats demanding poultry farms to go for land conversion, classifying it as manufacturing activity.

This is a welcome move for which the KPFBA thanks the Government for the circular and hopes that Karnataka will further come up with progressive policies which will help the poultry sector to grow exponentially.


The KPFBA had clarified to the government that poultry farming is defined as agriculture in Section 2-(a)(1)(d) of the Land Reforms Act, 1961. The KPFBA had been making several representations to various government bodies opposing the draft Karnataka Gram Swaraj and Panchayat Raj (gram panchayat's tax, rate and fees) Rules, 2021. The KPFBA had pointed out that "Poultry farming has not been defined under the Karnataka Grama Swaraj and Panchayath Raj Act 1993. Poultry Farming is defined under the Karnataka Land Reforms Act i.e., under Section 2(1)(d) of the said Act."

Poultry farms cannot be included in 'Agricultural-Based Manufacturing Units'.

The KPFBA said "From perusal of the definition clause at Rule 2(3) it is seen that, Poultry Farm, has been included under the definition of Buildings used for Agricultural-Based Manufacturing Units. Upon defining the Poultry Farm as Agricultural-Based Manufacturing Unit, it has been made assessable to Taxes under Chapter III, Rule 15(4). However. the Karnataka Revenue Act does not mandate for conversion of the lands where Poultry Farms are constructed, as poultry farming itself is agriculture and poultry farms are mostly agricultural lands."

The KPFBA insisted that poultry farming is not a commercial activity, but an agricultural activity, much like other periodical agricultural activities.

"Poultry farming is not manufacturing process where some agricultural raw materials are used, processed and a new product is manufactured. It is an agricultural activity much like sericulture where silk worms are cultivated to produce silk." The KPFBA said that to raise a batch of chicks in to consumable chickens, it takes about 35 to 40 days.



Thereafter to rear the next batch of chicks there must be a gap of about one and a half months. In a year, a farmer can rear chicks in five batches, maximum.

High Court judgment on 'right to construction up on agricultural land'

The KPFBA had cited the judgment of the High Court of Karnataka in E.Bhaskar Rao Vs. State of Karnataka wherein the former challenged the revenue authorities who demanded Rs. 7,01,283 towards land conversion fine. The High Court held that the occupant of a land held for agricultural purpose has 'right to put up construction for his farm house and quarters for labourers etc as poultry farm activities are equated with agricultural activities.'



Maharashtra Association gets new office-bearers Mr. Vasanthkumar honoured for exemplary leadership





Combating emerging diseases of metabolic and infectious origin in broiler breeders

The Karnataka Poultry Farmers and Breeders Association (KPFBA) in association with Virbac organized a knowledge session on "Emerging Diseases of Metabolic & Infectious Origin in Broiler Breeders" by Dr. Nitin Kurkure, Director of Research, Maharashtra Animals & Fishery Sciences University.

Dr. Kurkure said that there is a global loss of about 2.4 billion US dollars in poultry industry alone due to coccidian infections. Each year, over 50 billion chickens are raised as a source of meat, accounting for over one-third of protein food for humans. Avian coccidiosis is one of the important disease, which causes harm to the industry throughout the world. As global animal production has rapidly shifted towards reduced antibiotic usage, health" popular "gut has become expression and all-encompassing concept in scientific community. The gastrothe provide a barrier intestinal tract must function protecting harmful against environmental elements (e.g. toxins and

pathogenic microbes), while simultaneously permitting appropriate nutrients to the birds.

Panel discussion

In the panel discussion, Dr. Harsha Kumar Shetty, General Manager, Sales and Tech Support (Parent stock), Venkateshwara Hatcheries; Dr. Jitendranath Saha, General Manager, Marketing, Virbac Animal Health India; and the moderator Dr. R.N.S.Gowda, former Vice Chancellor, KVAFSU, Bidar, spoke on modern poultry production, the challenges and the risks.

The panellists said that modern poultry production now has the ability to control most infectious diseases. World-wide non-infectious diseases like metabolic disorders are emerging which are causing mortality in birds with the rapid growth rate or the highest egg yield. Metabolic disorders which affect skeletal development have also now become important issues in many countries, including India.



PERSON OF THE MONTH: KISHORE KUMAR HEGDE

DRIVING LIFELINE FEEDS TO GREAT HEIGHTS

Leadership and vision make great companies. That exactly is the story of Kishore Kumar Hegde, Chairman and Managing Director of Lifeline Feeds, a company to reckon with, in the poultry sector. The vision he has set forth for Lifeline Feeds – 'Hatch to Health' is pegged on to quality as he believes quality, along with other ethical business traits, catapults a company to commanding heights. Lifeline Feeds has an annual turnover of Rs. 350 crores and has 1000 plus workforce.

Kishore Kumar's journey has interesting twists. After graduation, he was entrusted the job of running a hotel which his father had started in partnership. That didn't do that well. However, it was here he bumped into Prof. Ponnappa, the founder of Sudarshan Feeds. Enthused by the business, he took up distributorship of Sudarshan Feeds in Chikmagalur. And in 1985, he took distributorship of Om Traders, visiting poultry and other farms. All this happened when he was all of 20 years of age.

Then came the inflection point. In 1987, he set up his own poultry farm with 3,000 birds for research in feeds and management. In 1995, he expanded the business, going up to 20,000 birds, thus setting the trend for bulk production of broilers. There has been no looking back as Kishore Kumar invested time, effort and money in growing the business.

Inspired by industry giants such as Ratan Tata, Azim Premji, Narayana Murthy and others, Kishore Kumar Hegde kept his philosophy simple — to do ethical business and provide quality products. This has paid dividends. And he is ever active to grow his business, right from his youthful days. In 1997, he and Arvind Bhat started Nandan brand of cattle and poultry feeds. Alongside was hatchery and breeding, but off-season order issues were there. It was then he came up with the idea of contract farming where the company took the full responsibility of rearing and buying, first of its kind in Karnataka. It became a hit.

In 2002, they started online processing and retailing, first in Chikmagalur and in 2005, extended Lifeline's Tender Chicken operations in Bangalore and other cities. Success just followed their outlets as it was a cool concept where anyone could walk in to a neat and 'well designed' retail unit and buy fresh and quality chicken, away from some retail vends which need to rework their environments. The next year, he put up a state-of-the-art slaughtering facility in Chikmagalur with a capacity of 1,800 birds per hour and in 2012-13 started a modern feed mill, rendering plant and German cold torage system. He was bringing in the best of technologies to grow the business and the rewards are there for all to see.

Kishore Kumar Hegde is not just an astute business person, but a fine human being who has been constantly making charitable contributions. One highpoint of his life has been of the 150 children he had adopted, about 30 have turned out to be doctors and many as engineers. There cannot be a better way of serving the community that gives you opportunities to grow and let others grow.

The KPFBA President also thanked Dr. Dilip Kumar and the team from Virbac for sponsoring the Knowledge session.





RECIPE: Creamy Garlic Chicken Breast Recipe

- 3 Large Boneless And Skinless Chicken Breasts (halved horizontally to make 4)

- 1 1/4 cups Chicken Broth (stock)
- 1 1/4 cups Heavy Cream (or half and half, or evaporated milk)
- ½ cup Fresh Parmesan Cheese (finely grated)
- 2 tablespoons Fresh Parsley (to serve)
